Perspectives on German-US Relations: Pasts, Presents, & Futures

A Symposium Hosted by the Gustav-Stresemann-Institute (Bonn, Germany) and Wartburg College (Waverly, IA) on March 18, 2019, at Wartburg College

From today's headlines with the focus on US tariffs on European steel and aluminum imports, the US pulling out of the Paris Climate Agreement, and the US withdrawal from the Iran nuclear deal, it appears that the USA and its close allies, including Germany, are approaching a new low point. However, this is not the only way to view the connections between Germany and the USA for these headlines only cover part of a long, rich, complex, and varied story. Building upon the conclusions and insights gained from the joint Gustav-Stresemann-Institute and Wartburg College symposium, "From Rebels to Democrats – A New Look at an Old Relationship. German-American Relations from 1848 to the Present," held in March, 2018, in Berlin, Germany, this new symposium seeks to continue the conversation. In Berlin, the one-day symposium discussed the German-American relations from 1848 until today and outlined the future of the transatlantic relationship primarily from the German perspective. In Waverly, we will expand our understanding of German-US relations by examining additional pasts, presents, and futures with an emphasis on historical, political, economic, cultural, journalistic, and personal perspectives. Precisely because of today's headlines and the challenges both countries face as they move into the future, an exploration of the multifaceted nature of US-German relations is essential.
